Fees: \$45 per session (includes both tests, and judges written and verbal comments).

All tests will be ridden in a small arena (20m x 40m), indoors. Choose any test (USDF, USEA or Pony Club) and any level that you desire. Classes will be grouped by levels as near as possible.

Attire is casual but tidy. USAE rules apply for equipment, tack and horsemanship. Warm up will be outside around trailers and parking lot, there will be a small area to warm up inside for next horse to ride. Additionally the next horse to go can warm up outside the arena during the previous rider's mini lesson. Times will be emailed no later than 4 days prior to show date.
